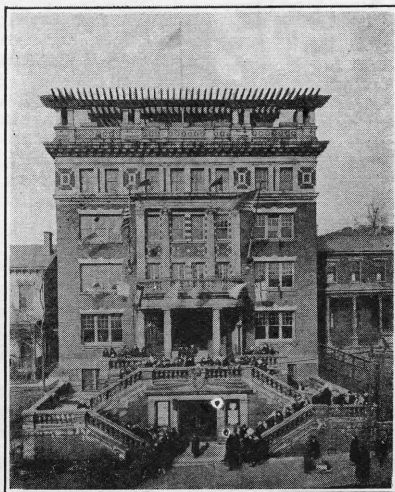


Irene Kaufmann Settlement

IRENE KAUFMANN SETTLEMENT

The real organization of the Irene Kaufmann Settlement was April 27, 1900, and then it was known as the Columbian Council School. The first resident director was Miss Julia Schoenfeld, who was followed by Miss Sadie Levy, Miss Yetta Baumgarten, Miss Addie Weihl, Albert Baron, Miss Elizabeth Neufeld and Samuel Leff. In 1914, Miss Schoenfeld again took charge, to be succeeded by Sidney A. Teller, the present Resident Director. In 1909, Mr. and Mrs. Henry

Kaufmann erected a new building for the settlement as a memorial to their daughter, Irene Kaufmann. It has grown with each succeeding year, and its activities have spread into numerous and diverse channels. Mr. Teller has brought the Irene Kaufmann Settlement before the public, and its beneficial work in the Hill District is prominently known.
